What is SUAA Foundation and what is its Purpose?

SUAA Foundation is a 501(C)(3) affiliated with SUAA that focuses on providing the following services as deemed desirable, beneficial and fundable as determined by the Foundation Board of Directors.

- Education and information regarding legislation and social issues affecting the welfare of the members of SUAA.
- Emergency assistance to SUAA members who are in need of financial support.



SUAA Foundation Emergency Assistance Fund



The SUAA Foundation Emergency Assistance Program is designed to help chapters provide support for members who are facing a sudden need for funds to cope with a crisis situation. Chapters may request assistance of up to \$1,500 on behalf of individuals who have been SUAA members for 5 years or more.

Below are the steps to request assistance.

1. Write a Cover Letter

In the cover letter, please tell the Evaluation Committee about the situation for which your member needs our financial assistance. Describe what overall aid the member is requesting, how it will be used, and what the chapter is doing to help. Include whether Insurance will be available to cover some of the costs.

Please type the cover letter and the application.

2. Fill out the Application

The application is on the SUAA website at SUAA.org and click on Foundation. On the application form, summarize what funds are needed, how they will be used and what the chapter and its members are contributing to assist the applicant.

Some grants can be subject to taxes. If the funding is approved, the SUAA Foundation Treasurer may need the recipient's' Social Security number and other data for our records.

3. Submit Both Documents Online
