#3) Election - Alice Medenwald	The 2019 SUAA Executive Committee Ballot was distributed by Alice Medenwald Motion to accept ballot – Gary Davis, Seconded by Pat Asher President - There was a unanimous endorsement of Jan Cook for President Treasurer - Jan Cook appointed Narbeth Emmanuel as Treasurer Members at Large Election - There were no additional nominations from the floor. Andy Small, H.F. Williamson, Sally Mullan, were unanimously elected by a show of hands as Members at Large

#4) Treasurer's Report – Jan Cook	Report presented by Jan cook on behalf of Janice Nobbe. Jan discussed a contractual agreement with our financial service provider. A motion to enter into a contract was made by H.F Williamson – seconded Sally Mullan • Jan stated we had an increase in donations this past year • Net balance has been stable with over \$100,000 for several years • A question was raised as to why we do not invest in CDs? There aren't any rules in the by-laws restricting this action. Jan and Narbeth will review the matter. • A motion was made by Gary Davis to send Janice a note for all her hard work over the years – seconded by H.F. Williamson. Jan Cook said she would send Janice the thank you note on our behalf.

#6) Chair's Report	 Jan shared the card that was developed for donors of the SUAA Foundation. She pointed out that in its current state, is does not qualify as a tax receipt. The scholarship program was launched on the SUAA website in March or April. To date, 15 applications were received but only 14 were complete. There is a committee of 5 screening the applications. Scholarships decisions will be made in mid-July. The committee will send letters to each applicant regarding their application outcome. The scholarship should be used as a recruitment tool. HF Williams thanked Alice for all of her hard work on this endeavor.
